Widening the Reach of EU Missions Through EEA and Norway Grants

Widening countries are crucial for the success of the European Missions – can EEA and Norway Grants help create synergies and inclusion?

Background

Norway, together with Iceland and Liechtenstein, have through the EEA and Norway Grants supported numerous initiatives in Widening countries since 2004, including bilateral research programmes, climate and environmental programmes, business, and regional development programmes. During the current funding period (2014-2021), the EEA and Norway Grants channelled 2,8 billion EUR to over 6000 projects. (www.eeagrants.org)

The Research Council of Norway (RCN) has acted as donor programme partner in bilateral research programmes since 2006 and developed close relations to several sister organisations in Widening countries that are administrating these EEA and Norway Grants programmes.

Together, RCN and these organisations carried out a series of events in 2023 to boost Widening participation in EU Missions and Horizon Europe by reducing the information lag, bringing updated information about the Missions activities and plans, and by showcasing that capacity and expertise relevant for the Missions has been established in many EEA and Norway Grants projects.

The events covered all the 5 EU-Missions: Cancer Mission in Bucharest (14-15.02.2023 by UEFISDI), Soil Mission in Prague (18.09.2023 by TACR) and Ocean Mission in Portugal (17th October 2023 by DGPM), Climate Adapt and Cities Mission in Warsaw (21-22nd November 2023 by NCBR). Their primary target group were participants from EEA and Norway Grants projects that are thematically relevant to the Missions.

Goal

We believe that there is a synergy potential between the investments in capacity in Widening countries made by the EEA and Norway Grants and the EU Missions. We also believe that we all need to act to address the information, coordination, and implementation lags, which are affecting the participation of Widening countries in new and emerging Horizon Europe and ERA initiatives, including the EU Missions.
