1. INTRODUCTION

Through the EEA and Norway Grants, Iceland, Liechtenstein and Norway make available grant funding to 16 beneficiary countries. In the period 2009-2014, this amounts to 1.8 billion. Funding is channeled through 150 programmes. Projects under the programmes may be implemented until 2016/2017.

Grants are disbursed in accordance with the Regulations on the implementation of the EEA and Norway Grants 2009-2014 (the 'Regulations'), and an agreement between the beneficiary countries and the donor countries, the 'Memorandum of Understanding'. All beneficiary countries designate a National Focal Point, which is the national authority having the overall responsibility for reaching the objectives and implementing the Grants in the respective country. The National Focal Points represent the beneficiary countries vis-à-vis the donors.

In addition to the National Focal Point, the beneficiary countries designate a Certifying Authority, which is charged with submitting financial reports to the donors; an Audit Authority, charged with carrying out audits to ensure the effective functioning of the management and control systems designed by the beneficiary countries; and a national entity responsible for the reporting of irregularities.

Hence, the overall responsibility for reaching the objectives of the EEA and Norway Grants 2009-2014 lays with the beneficiary countries' authorities. The latter are also responsible for the prevention, detection and correction of any cases of irregularities. The designated national public entity responsible for the preparation and submission of irregularities reports on behalf of the beneficiary country reports actual and suspected cases of irregularities to the donors on a quarterly basis. More serious irregularity cases, involving for example corruption or fraud, should be reported to the donors immediately.

Most programmes are managed by Programme Operators, coming mainly from the beneficiary countries. However, the Financial Mechanism Office (FMO), which acts as a secretariat for the

Grants, also operates some programmes. In such cases the implementation of the programme is delegated to a Fund Operator.

Ensuring openness and transparency is essential for the implementation of the Grants and to keep the public informed on the achievements of the funding. The overview of all closed irregularity cases, including irregularities reported by the beneficiary countries and the Fund Operators, as well as irregularities detected by the FMO during the exercise of its control functions, will be updated and published on www.eeagrants.org on a quarterly basis.

This report provides an overview of all closed irregularity cases from 1 January 2014 to 31 December 2019.

2. SCOPE OF IRREGULARITIES

With large volumes of grant-making and numerous organisations involved, the Grants carry an inherent risk. The Grants are contributions from public resources in the donor countries and a zero-tolerance to corruption and mismanagement has always been a guiding principle underlying the implementation of the Grants.

Irregularities are defined in the Regulations as any infringement of the legal framework of the EEA and Norway Grants 2009-2014, of any provision of European Union law or of any provision of the national law of the beneficiary country, which affects or prejudices any stage of the implementation of the Grants in the beneficiary country, in particular, but not limited to, the implementation and/or the budget of any programme, project or other activities financed by the Grants. This entails that the nature of the irregularities that are looked into can vary significantly.

There are also significant differences in the number of irregularity cases reported by each beneficiary country or Fund Operator. This highly depends on the implementation stage of the various programmes, but also on the efficiency of the management and control systems at country/programme level in the detection of irregularities.

Irregularities may consist of errors or fraud. While errors are often unintentional mistakes, fraud entails deliberate deception for the purpose of making an unjust gain.

3. OVERVIEW OF CLOSED IRREGULARITY CASES

In the period from September 2013¹ to 31 December 2019, 1036 irregularity cases have been reported. Out of these, 981 irregularity cases have been closed. Investigations that have been concluded are referred to as 'closed cases'. Among the closed irregularity cases, most relate to errors; 27 cases refer to fraud. 138 closed cases refer to deviations from the programme agreement; 291 refer to deviations from the project contract; 330 refer to deviations from public procurement procedures and 195 refer to errors in payment claims. Many of the country or programme level irregularity cases reported do not have any impact on the payments made from the Grants.

4. OVERVIEW OF RECOVERED AMOUNTS AND GRANT REDUCTION AMOUNTS

If any resources are unduly paid or lost due to corruption, fraud or mismanagement, the beneficiary country or the Fund Operator are responsible for reclaiming them from the Programme Operator or project promoter, depending on who committed the irregularity.

In accordance with the Regulations, the beneficiary country and the Programme Operators, as well as the Fund Operators shall make every effort possible to prevent, detect and nullify the

effect of any cases of irregularities, including by making financial corrections that may be appropriate. Financial contributions cancelled in projects may be reused under the programme for projects other than those that were the subject of a financial correction. The project grant amount is thus reduced in case of financial corrections. However, when a financial correction is made for systemic irregularities, the financial contribution may not be reused for that programme. This means that the programme grant amount is reduced.

In cases of fraud or corruption, the entire project would be closed down, and the amounts already reimbursed to the Project Promoter would have to be paid back.

Between 1 January 2014 and 31 December 2019, the reduction of project grants has amounted to € 12,871,208. The reduction of programme grants has amounted to € 311,019. € 201,975 were recovered by the FMO.

5. OVERVIEW OF FRAUD CASES

In the period from September 2013 to 31 December 2019, 29 irregularity cases have been reported as referring to fraud – deliberate deception for the purpose of making an unjust gain-, including suspicion of fraud. Of the closed irregularity cases during the reporting period, 27 concerned fraud, including suspicion of fraud.

IR-0278: Suspicion of fraud concerning the non-implementation of the project activities in line with the project contract.

IR-0281: The project promoter failed to submit the project report.

IR-0885: Collusion affecting public procurement procedures.

IR-0928: Absence of appropriate supporting documents; suspicion of fraud and embezzlement. The case is linked to IR-0100, IR-0169 and IR-0263.

IR-0996: Suspicion of fraud as to the organization of two events by the same service provider.

IR-1004: Collusion and project mismanagement.

IR-1067: Possible falsification of documents.

IR-1088: Suspected collusion between bidders.

6. OVERVIEW OF ERROR CASES

Besides the 27 cases concerning fraud, all the closed irregularity cases are related to errors. An error is any non-compliance with the conditions for receiving the grant at country, programme or project level, and does not necessarily mean that funds have been lost or wasted.

When several identical errors occurred within the same project/similar activities under programme level expenditure, these have been merged into one single case in tables 4 to 7 below. One listed case might therefore include several occurrences of error.

In tables 4 to 7 below, under the column 'Country', Fund Operators managing programmes in a given beneficiary country on behalf of the FMO are also included.

6.1 DEVIATION FROM PROGRAMME AGREEMENT

For each programme financed by the Grants, a programme agreement is concluded between the donors and the National Focal Point or, in the case of programmes operated by the FMO, the Fund Operator.

Errors under this category are often of a formal or procedural rather than financial nature, and may therefore often be corrected without any financial sanctions.

Deviation from the programme agreement could include inter alia non-compliance with agreed procedures for the selection, monitoring or follow-up of projects or irregularities concerning country/programme level expenditure (e.g. bilateral funds or complementary action).

For each project financed under a programme, a project contract is concluded between the PO or, in the case of programmes operated by the FMO, the Fund Operator and the project promoter.

A deviation from the project contract refers to non-compliance with the contractual terms, for example as regards reporting, planned progress of the project, any specific conditions set out in the contract (environmental conditions, building permissions), etc.

6.3 DEVIATION FROM PUBLIC PROCUREMENT PROCEDURES

A deviation from public procurement procedures could imply the inadequate assessment of bids, absence of tendering or inapproapriate use of tendering procedures.

If a breach of the public procurement procedures is detected, national authorities are required to apply financial corrections as appropriate, including flat rate corrections set as a percentage of the value of the contract in question.

6.4 ERRORS IN PAYMENT CLAIMS

Errors affecting payment claims could include cases where there are mistakes in the payment claims submitted to the Programme Operator/Fund Operator, for example mistakes in the calculation of depreciation to be charged to the project, mistakes in the use of the applicable exchange rate, inclusion of ineligible costs etc.
