### Eligible Priority Sectors and Programme Areas

#### Norwegian Financial Mechanism

The overall objectives of the Norwegian Financial Mechanism 2014-2021 are to contribute to the reduction of economic and social disparities in the European Economic Area and to strengthen bilateral relations between Norway and the Beneficiary States through financial contributions in the priority sectors and programme areas listed below.

Each of the five priority sectors includes a number of programme areas. Each of the 23 programme areas includes an objective, areas of support and programme area specifics.

Each programme and any project funded through it shall contribute to the objective of the programme area.

The areas of support define what is eligible under the programme area.

The programme area specifics are conditions which shall be adhered to within the programmes.

Programmes can focus on a single programme area or alternatively they can combine a number of areas of support from various programme areas in an individual programme, as long as all measures under the programme contribute to the same objective.

The below priority sectors and programme areas are eligible for the Norway Grants 2014-2021.
