The Committee (EEA Financial Mechanism) and the Norwegian Ministry of Foreign Affairs (NMFA) decided on reallocation requests between programmes. Reallocation requests had been received from Poland, Romania, the Czech Republic, Bulgaria, Lithuania and the Slovak Republic.

5.2 Delegation of tasks from the FMC to the FMO

The Committee adopted the modifications to the FMC Decision of 25 January 2012 'Concerning the of 25 January 2012 'Concerning the delegation of tasks contained in the Legal Framework of the EEA Financial Mechanism 2009-2014 from the Financial Mechanism Committee to the Financial Mechanism Office'.

5.3 Semi-annual meeting with EU Agency for Fundamental Rights - mandate

The Committee endorsed (i) the mandate for EEA &Norway Grants delegation attending the semi-annual coordination meeting with the EU Agency for Fundamental Rights on 23 October 2014 and (ii) the draft Framework Co-operation Agreement between the FMO and FRA.
