ABOUT THE PROJECT

WHY: Poor young people without financial support have difficulties with continuing their education or enrol for out-of-school courses due to financial reasons. Worst off are orphans that are out of social protection facilities at the age of 18, children of working poor people that are financially depend on their parents, young people in rural areas with limited access to specialised education and training, young single parents, young people with physical health problems, and some minority groups. There is a need to find a way to ensure that all young people have equal access to education and jobs.

WHAT: The project partners will develop and run an innovative training programme for specialised digital competences such as digital design and skills, graphics, 3D animation, game design etc. for young people that otherwise cannot afford to obtain a hi-tech education due to poverty. The programme will be created together with business supporting organisations with focus on the creative industries,

Target groups:

- Vulnerable young people at poverty risk, orphans that are out of social protection, and children of working poor people
- Young people in rural areas, young single parents, and young graduates at poverty risk
- Poor young people belonging to minority groups

ABOUT THE FUND

The €60 million EEA and Norway Grants Fund for Youth Employment supports transnational project initiatives that promote sustainable and quality youth employment in Europe. The focus on transnational cooperation reflects the view that unemployment among youth is a common European challenge and common European solutions should therefore be explored.

The fund seeks to complement existing EU funding on youth employment initiatives, e.g. the long-term unemployed in the age group 25-29.

The selected projects aim to:

- Make it easier for 25 000 young people to find a job
- Create 3500 jobs in NGOs and social enterprises
- Help 1800 young people start up their own business

The 27 selected projects involve partners from all the 15 beneficiary countries of the EEA and Norway Grants as well as Ireland, Italy and Spain – all countries with high youth unemployment. The projects also include expertise partners from the donor countries Iceland and Norway as well as two international organisations and other EU member states.
