**ABOUT THE PROJECT**

**WHY:** Cyprus, Italy, Greece and Portugal have weak systems on career planning, entrepreneurship education and validation of non-formal learning. Experience from other European countries has shown that such initiatives increase the employment opportunities of young people.

**WHAT:** The Partners from Poland, Lithuania and Austria will share their work on these topics and support the establishment of Job Labs and Entrepreneurship Labs that will help 1400 young people into education or a job. The project will also establish systems for validation of non-formal learning. The aim is to draw experience from the Youthpass certificate but extend its impact in terms of target groups, scope, and level of innovation

**ABOUT THE FUND**

The €60 million EEA and Norway Grants Fund for Youth Employment supports transnational project initiatives that promote sustainable and quality youth employment in Europe. The focus on transnational cooperation reflects the view that unemployment among youth is a common European challenge and common European solutions should therefore be explored.

The fund seeks to complement existing EU funding on youth employment initiatives, e.g. the long-term unemployed in the age group 25-29.

The selected projects aim to:

- Make it easier for 25 000 young people to find a job
- Create 3500 jobs in NGOs and social enterprises
- Help 1800 young people start up their own business

The 27 selected projects involve partners from all the 15 beneficiary countries of the EEA and Norway Grants as well as Ireland, Italy and Spain – all countries with high youth unemployment. The projects also include expertise partners from the donor countries Iceland and Norway as well as two international organisations and other EU member states.

**ABOUT THE EEA AND NORWAY GRANTS**

The EEA and Norway Grants represent the contribution of Iceland, Liechtenstein and Norway to reducing economic and social disparities and to strengthening bilateral relations with 15 EU countries in Central and Southern Europe and the Baltics.
