### **ABOUT THE PROJECT**

WHY: Some young people have a harder time getting good education and finding a good job than others. It may be due to a physical or psychological disability, or poverty, or lack of skills. Immigrants and refugees have problems because they often do not speak the languages of their new countries, and many minority groups are discriminated against. Many young people have specific needs that the ordinary education systems cannot handle and usually these groups may not be attractive to ordinary employers.

WHAT: The project partners will make apprenticeships and training opportunities that are better suited to the specific needs of young people who fall outside the ordinary education systems. They will train the youngsters in social enterprises, which are businesses that are more concerned with social changes than with making a profit. The model used is called WISE (Work Integration Social

## ABOUT THE FUND

The  $\bigcirc$ 60 million EEA and Norway Grants Fund for Youth Employment supports transnational project initiatives that promote sustainable and quality youth employment in Europe. The focus on transnational cooperation reflects the view that unemployment among youth is a common European challenge and common European solutions should therefore be explored.

The fund seeks to complement existing EU funding on youth employment initiatives, e.g. the long-term unemployed in the age group 25-29.

The selected projects aim to:

- Make it easier for 25 000 young people to find a job
- Create 3500 jobs in NGOs and social enterprises
- Help 1800 young people start up their own business

The projects also include expertise partners from the donor countries Iceland and Norway as well as two international organisations and other EU member states.
